

## **OFFICIAL RULES FOR “GAMESTOP® POWERUP REWARDS™ HAULIDAY SWEEPSTAKES”**

### **NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.**

1. The “GameStop® PowerUp Rewards™ Hauliday Sweepstakes” (“Sweepstakes”) begins 12:00 AM Eastern Time (“ET”) November 4, 2018 and ends 11:59 PM ET December 1, 2018 (“Sweepstakes Period”). The Sweepstakes Period will be divided into four (4) weekly entry periods (each an “Entry Period”, as outlined in the chart in Section 4 below).

2. Open only to legal residents of the 50 United States and the District of Columbia who are 18 years of age or older at the time of entry. Void where prohibited by law. Employees of Trymark Consulting Group, L.L.C. and their respective parents, affiliates, subsidiaries, advertising and promotion agencies, retailers, distributors and suppliers, and the immediate families (spouse, parents, children and siblings and their respective spouses, regardless of where they reside) and individuals living in the same households of such employees, whether or not related, are ineligible to enter or win. (i) Log into your GameStop® PowerUp Rewards™ Member account (or, if not an existing PowerUp Rewards™ member, follow the instructions provided at <http://www.gamestop.com/gs/landing/powerup/> to join). Then, redeem accrued points for entry into the Sweepstakes as follows: two hundred (200) points to receive one (1) entry; one thousand (1,000) points to receive seven (7) entries; or two thousand (2,000) points to receive fifteen (15) entries. The number of points redeemed for entry will be deducted from your GameStop account. No points will be refunded or credited to your GameStop account once redeemed. You will not be permitted to submit any number of entries into the Sweepstakes if you do not have the required number of points to redeem for entries into the Sweepstakes. Online entries must be received by the end date and time specified for the applicable Entry Period (as outlined in the chart in Section 4 below) to be eligible via this method of entry.

(ii) To enter the Sweepstakes without a GameStop® PowerUp Rewards™ Member account, go to <https://gamestop.trymarkapps.com/gsa/hauliday>, enter your date of birth, then complete and submit the entry form by providing your first and last name, street address, city, state, zip code, phone number (including area code) and e-mail address to receive two (2) entries into the Sweepstakes. Submission of erroneous or incomplete information will void the entries. All Entries become the property of the Sponsor and will not be acknowledged or returned. Online entries must be received by the end date and time specified for the applicable Entry Period (as outlined in the chart in Section 4 below) to be eligible via this method of entry.

Limit one hundred twenty-five (125) entries per person, per household and per e-mail address per Entry Period, regardless of method of entry. All entries become the property of GameStop, Inc. (the “Sponsor”) and will not be acknowledged or returned. If entries are received in excess of the stated limitation from any person or household or e-mail address during any Entry Period, regardless of method of entry, only the first one hundred twenty-five (125) entries received from such person or household or e-mail address will be eligible for entry for that Entry Period. Should multiple users of the same e-mail account enter the Sweepstakes and a dispute thereafter arises regarding the identity of the entrant, the authorized account subscriber of said e-mail account at the time of entry will be considered the entrant and required to comply with these Official Rules and all requirements set forth herein. “Authorized account subscriber” is defined as the natural person who is assigned an e-mail address by an Internet access provider, on-line service provider or other organization, which is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

4. **Random Drawings:** A random drawing for Weekly Prizes (as described in the chart below in section 5) will be conducted from among all eligible entries received at the conclusion of each Entry Period as outlined in the chart below. Drawings will be conducted by Trymark Consulting Group, L.L.C., an independent judging organization whose decisions are final and binding. Odds of winning will depend on

EXCEPT WHERE PROHIBITED BY LAW, AS A CONDITION OF PARTICIPATING IN THIS SWEEPSTAKES, YOU AGREE THAT A) UNDER NO CIRCUMSTANCES WILL YOU BE PERMITTED TO OBTAIN AWARDS FOR, AND YOU HEREBY WAIVE ALL RIGHTS TO CLAIM, PUNITIVE, INCIDENTAL, CONSEQUENTIAL, OR ANY OTHER DAMAGES, OTHER THAN FOR ACTUAL OUT OF POCKET EXPENSES, IF ANY; B) ALL CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS SWEEPSTAKES, OR ANY COMPENSATION OR CREDIT TO BE PROVIDED, SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION AND EXCLUSIVELY BY FINAL AND BINDING ARBITRATION IN ACCORDANCE WITH THE FEDERAL ARBITRATION ACT ("FAA", Title 9 of the United States Code) UNDER THE AUSPICES OF THE AMERICAN ARBITRATION ASSOCIATION; C) THE FEDERAL ARBITRATION ACT SHALL GOVERN THE INTERPRETATION, ENFORCEMENT AND ALL PROCEEDINGS AT SUCH ARBITRATION; AND D) JUDGEMENT UPON SUCH ARBITRATION AWARD MAY BE ENTERED IN ANY COURT HAVING JURISDICTION. YOU HAVE A RIGHT TO OPT-OUT OF THIS ARBITRATION PROVISION. IF YOU DO NOT AGREE TO THIS MANDATORY ARBITRATION PROVISION WITH REGARD TO THIS SWEEPSTAKES, THEN WITHIN THIRTY (30) DAYS FROM THE DATE OF YOUR ENTRY, YOU MAY OPT-OUT OF THIS, AND ONLY THIS, PART OF THE OFFICIAL RULES BY NOTIFYING THE SPONSOR OF SUCH OPT-OUT REQUEST BY PROVIDING WRITTEN NOTICE AND MAILING SUCH NOTICE TO: "GAMESTOP® POWERUP REWARDS™ HAULIDAY SWEEPSTAKES" – ARBITRATION REJECTION, P.O. TO THESE OFFICIAL RULES. ANY AND ALL CLAIMS, JUDGMENTS, AND AWARD SHALL BE LIMITED TO ACTUAL OUT OF POCKET COSTS INCURRED, IF ANY, AND IN NO EVENT SHALL YOU BE ENTITLED TO RECEIVE ATTORNEYS' FEES OR OTHER LEGAL COSTS OR EXPENSES.
